The applicant requested \$250,000 for the purchase of four Tyson mega barns in Graves County. The Murray Bank in Murray, KY is the participating lender.

Staff recommends approval, with combined loan-to-value of no greater than 85% and proof of Kentucky residency.

Beginning Farmer Loan Program (BFLP)

AF23-0080 Carrico, Payton

The applicant requested \$228,000 for purchase of 25.9 acres in Washington County. Central Kentucky ACA in Lebanon, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 95% FSA guarantee on CKACA and KAFC funds, with combined loan-to-value of no greater than 100%.

Mr. Jaggers moved to approve the staff recommendation, as presented; Mr. Flanagan seconded the motion.

VOTE: Motion Passed; Mr. Noe Abstained.

AF23-0108 Shields, James

The applicant requested \$250,000 for the purchase of 213 acres with improvements in Hardin County. Wilson & Muir Bank & Trust Co. in Bardstown, KY is the participating lender.

Staff recommends approval, combined loan-to-value no greater than 85%.

Mr. Lawson moved to approve the staff recommendation, as presented; Mr. Noe seconded the motion.

VOTE: Motion Passed; Unanimous.

AF23-0109 Clark, Caleb

The applicant requested \$106,875 for the purchase of 45 acres in Marion County. Central Kentucky ACA in Lebanon, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 95% FSA guarantee on CKACA and KAFC funds, with combined loan-to-value of no greater than 100%.

Dr. Burdine moved to approve the staff recommendation, as presented; Mr. Lawson seconded the motion.

VOTE: Motion Passed; Mr. Noe Abstained.

AF23-0111 Delaney, Dustin

The applicant requested \$126,750 for the purchase of 32 acres in Shelby County, KY. Independence Bank in Shelbyville, KY is the participating lender. This application was referred to the Loan Review Committee.

The Loan Review Committee recommends to not fund the application because the applicant was not substantially participating in the proposed operation per the guidelines.

Ms. Rumpke moved to approve the committee recommendation; Mr. Noe seconded the motion.

AF23-0112 Sparrow, Silas

The applicant requested \$224,00 for the purchase of 107 acres in Anderson County, KY. Farm Credit in Shelbyville, KY is the participating lender.

Staff recommends approval, with combined loan-to-value no greater than 85%.

AF23-0114 Garrett, William "Ted"

The applicant requested \$145,050 for the purchase of 108 acres in Marion County, KY. Central Kentucky ACA in Lebanon, KY is the participating lender. This application was referred to the Loan Review Committee.

The Loan Review Committee recommends approval contingent upon a 15 year term with 25 year amortization and making a principal and interest annual payment to KAFC in the first year.

Ms. Rumpke moved to approve the committee recommendation, as presented; Mr. Lawson seconded the motion.

AF23-0115 Bragg, Jared

The applicant requested \$74,250 for the purchase of 46 acres in Metcalfe County, KY. Cecilian Bank in Hiseville, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 90% FSA guarantee on Cecilian Bank and KAFC funds, with combined loan-to-value no greater than 100%.

Mr. Jaggers moved to approve the staff recommendation, as presented; Ms. Rumpke seconded the motion.

VOTE: Motion Passed; Unanimous.

AF23-0116 Geralds, Gary

The applicant requested \$250,000 for the purchase of 134 acres in Monroe County, KY. Bank of Columbia in Columbia, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 95% FSA guarantee on Bank of Columbia and KAFC funds, with combined loan-to-value no greater than 100%.

Mr. Noe moved to approve the staff recommendation, as presented; Ms. Rumpke seconded the motion.

VOTE: Motion Passed: Unanimous.

AF23-0117 Robertson, Blake

The applicant requested \$250,000 for the purchase of 377 acres in Todd County, KY. The First Financial Bank in Louisville, KY is the participating lender.

Staff recommends approval, with combined loan-to-value no greater than 85%.

Mr. Aldridge moved to approve the staff recommendation, as presented; Mr. Flanagan seconded the motion.

VOTE: Motion Passed; Unanimous.

AF23-0119 Buck, Travis

The applicant requested \$61,500 for the purchase of 38 acres in Monroe County, KY. Farm Credit in Glasgow, KY is the participating lender.

Staff recommends approval, with combined loan-to-value no greater than 85%.

Mr. Flanagan moved to approve the staff recommendation, as presented; Mr. Jaggers seconded the motion.

VOTE: Motion Passed; Unanimous.

Diversification through Entrepreneurship in Agribusiness Loan Program (DEALP) AF23-0113 Stogner, Eric

The applicant requested \$150,000 for the purchase of remaining 50% of share of Mid America Grain Solutions in Daviess County, KY. Independence Bank in Owensboro, KY is the participating lender. This application was referred to the Loan Review Committee.

The Loan Review Committee recommends approval as the application was presented.
