Staff recommends approval, contingent upon the sale of the retail store, the payoff of KAFC loan AF22-0084 and KAFC aggregate balance no greater than \$250,000, with combined loan-to-value no greater than 85%.

Mr. Roberts referenced the above application requesting \$250,000 for the purchase of 15 acres in Webster County. Field & Main Bank in Henderson, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 95% FSA guarantee on Field and Main Bank and KAFC funds, with a combined loan-to-value no greater than 100%.

## AF24-0025 Pepper, Branden

Mr. McCloskey referenced the above application requesting \$100,000 for the purchase of 110 acres in LaRue County. Farm Credit in Elizabethtown, KY is the participating lender.

The applicant failed to purchase the property at auction and has since withdrawn the application. No action required.

# AF24-0026 Hodges, William "Brad"

Ms. Randolph referenced the above application requesting \$250,000 for the purchase of 294 acres in Green County. Farm Credit in Campbellsville, KY is the participating lender.

Staff recommends approval, with combined loan-to-value no greater than 85%.

Ms. Noel moved to approve the staff recommendation, as presented; Mr. Aldridge seconded the motion

VOTE: Motion Passed; Unanimous.

#### AF24-0027 Farmwald, Jason

Mr. Roberts referenced the above application requesting \$250,000 for the purchase of 118 acres in Ohio County. Bank of Columbia in Columbia, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 90% FSA guarantee on Bank of Columbia and KAFC funds, with a combined loan-to-value no greater than 100%.

#### AF24-0028 Ayer, Kyle

Ms. Randolph referenced the above application requesting \$192,500 for the purchase of 43 acres in McLean County. Farm Credit in Owensboro, KY is the participating lender.

Staff recommends approval, with combined loan-to-value no greater than 85%.

Mr. Hunt moved to approve the staff recommendation, as presented; Mr. Rink seconded the motion

## AF24-0029 Sisk, Jonah

Mr. Roberts referenced the above application requesting \$250,000 for the purchase of 19 acres with four Tyson broiler barns with improvements in McLean County. Farm Credit in Owensboro, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 95% FSA guarantee on FCMA and KAFC funds, with a combined loan-to-value no greater than 100%.

#### AF24-0030 Rudnick, Jared

Mr. McCloskey referenced the above application requesting \$250,000 for the purchase of 54 acres with two Perdue egg barns in Hart County. Farm Credit in Hardinsburg, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 90% FSA guarantee on FCMA and KAFC funds, with a combined loan-to-value no greater than 100%.
