AF24-0129 Arnett, Ricky

Ms. Randolph referenced the above application requesting \$250,000 for the construction of 8 Tyson mega broiler barns in Green County. Farm Credit in Campbellsville, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 90% FSA guarantee on FCMA and KAFC funds, with a combined loan-to-value no greater than 100%.

Ms. Noel moved to approve the staff recommendation, as presented; Mr. Flanagan seconded the motion.

AF24-0131 Barton, Christopher

Mr. Roberts referenced the above application requesting \$45,614 for the construction of a Tyson breeder house in Allen County. Farm Credit in Glasgow, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 90% FSA guarantee on FCMA and KAFC funds, aggregate KAFC balance no greater than \$250,000, with a combined loan-to-value no greater than 100%.

Mr. Flanagan moved to approve the staff recommendation, as presented; Dr. Burdine seconded the motion.

AF24-0133 Critchelow, Andrew

Mr. McCloskey referenced the above application requesting \$141,863 for the conversion of 2 existing poultry houses to pullet houses in Breckinridge County. Farm Credit in Hardinsburg, KY is the participating lender.

Staff recommends approval, with a combined loan-to-value no greater than 85% and aggregate KAFC balance no greater than \$250,000.

Mr. Cochran moved to approve the staff recommendation, as presented; Dr. Burdine seconded the motion.

Ms. Randolph referenced the above application requesting \$130,313 for the conversion of 2 mega poultry houses to Perdue pullet houses in Breckinridge County. Farm Credit in Hardinsburg, KY is the participating lender.

Staff recommends approval, with a combined loan-to-value no greater than 85% and aggregate KAFC no greater than \$250,000.

Mr. McCloskey referenced the above application requesting \$250,000 for the purchase of 132 acres with 4 Tyson broiler barns in Taylor County. First Financial Bank in Fort Payne, AL is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 90% FSA guarantee on First Financial Bank and KAFC funds, with a combined loan-to-value no greater than 100%.

AF24-0130 McGuire, Whitney

Mr. Roberts referenced the above application requesting \$250,000 for the purchase of 59 acres and construction of a Vital layer barn in Graves County. The Citizens bank of Hickman in Hickman, KY is the participating lender. This application was referred to the Loan Review Committee.

The Loan Review Committee recommends denying the application due to not meeting the guideline requirements.

Mr. McCloskey referenced the above application requesting \$250,000 for the purchase of 24 acres with 2 Perdue breeder barns in Grayson County. Magnolia Bank in Elizabethtown, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 95% FSA guarantee on Magnolia Bank and KAFC funds, with combined loan-to-value no greater than 100%.

Ms. Noel moved to approve the staff recommendation, as presented; Mr. Aldridge seconded the motion.

AF24-0135 Hagan, Ryan

Mr. Jones referenced the above application requesting \$106,250 for the purchase of 28 acres in Union County. Farm Credit in Henderson, KY is the participating lender.
