# Kentucky Agricultural Development Board Summary Minutes of the Regular Business Meeting Franklin County Extension Office Frankfort, Kentucky June 16, 2017

#### **Call to Order**

Commissioner Quarles, presiding, called the Kentucky Agricultural Development Board (KADB) regular business meeting to order at 10:08 a.m. (EDT)

#### Roll Call

The following members were present: Commissioner Ryan Quarles, Dr. Betty Bailey, Dr. Kirk Pomper (designee for KSU President M. Christopher Brown II), Dean Nancy M. Cox, Stewart Hughes, Katie Smith (designee for Secretary Terry Gill), Bobby Foree, Pat Henderson, Jim Mahan, Wayne Mattingly, Sam Moore, Dr. Gordon Jones and Al Pedigo.

Members absent: Governor Matt Bevin, Wayne Hunt and Richard Warner.

Commissioner Quarles introduced KDA intern Ali Hulett.

#### **Notification of Media**

Commissioner Quarles received verification from Emily Milam, Public Relations Officer, that the media had been notified of the KADB monthly meeting.

#### Welcome

Commissioner Quarles welcomed everyone to the meeting.

Commissioner Quarles mentioned the June Dairy Month Proclamation.

Commissioner Quarles mentioned Commissioner's Comments, a monthly video series to promote agriculture on social media.

Commissioner Quarlès discussed tax reform and asked board members for suggestions.

Commissioner Quarles discussed potential reorganization from Kentucky Boards and Commissions that will impact KDA.

Commissioner Quarles referenced conversations with Secretary Gill, CED, involving the promotion of agriculture as economic development.

Commissioner Quarles recapped the 2017 KY FFA State Convention and 2017 4-H State Teen Conference.

Commissioner Quarles discussed the role of KDA in international trade.

Commissioner Quarles provided an update about the Southern Association of State Departments of Agriculture, as well as, the National Association of State Department of Agriculture.

Commissioner Quarles stated that it was the 25<sup>th</sup> year of the Agriculture in the Classroom Poster and Essay Contest and invited board members to attend the celebration at the Lexington Legends on Friday, June 16 at 7 p.m.

Dr. Bailey commented on the regional LAND meetings to link farmers, processors and manufacturers.

Mr. Rogers explained the LAND meeting and invited KADB members to register online and attend the meetings.

Commissioner Quarles also commented that KDA inspectors have found four credit card skimmers across the state.

Commissioner Quarles entertained a motion to approve the minutes of the May 19, 2017 board meeting.

Dr. Bailey moved to approve the minutes, as presented; Mr. Hughes seconded the motion.

## **Executive Director's Report**

Mr. Beeler introduced GOAP intern Sadie Middleton.

Mr. Beeler called on Aleta Botts, Executive Director, KCARD, to update the board on the activities of the organization.

Mr. Beeler called on Dr. Chad Lee, Director, UK Grain and Forage Center of Excellence, to update the board on the status of the center.

Mr. Beeler recognized Lowell Atchley, Senior Analyst, Legislative Research Commission, for his work with GOAP and acknowledged his upcoming retirement.

Mr. Beeler updated the board on the activities of the GOAP since the May 19, 2017 board meeting.

**Deputy Executive Director's Report** 

Commissioner Quarles yielded the floor to Bill McCloskey, GOAP Deputy Executive Director, to report to the board.

Mr. McCloskey updated the board on the activities at the National Governor's Association and the Learning Lab on Strategies to Reduce Childhood Hunger, aimed at combating childhood hunger at the state and local level.

Commissioner Quarles stated that due to recent legislation, Kentucky has the strongest food donation law in the country.

Mr. McCloskey directed the board's attention to the KBA PEP report from Ms. Gardner that shows the value of radio & TV commercials this year (on file).

Mr. McCloskey called on Ms. Gardner to deliver the Marketing and Entrepreneurship Committee Report.

Ms. Gardner reported that the Marketing and Entrepreneurship Committee met at 8:30 a.m. in Room C of the Franklin County Extension Office. The committee reviewed commodity group expenses from the previous year and requests for 2017 funds related to the KADF Promotional Fund. The committee also recommended participating in the KBA-PEP Program for a 6<sup>th</sup> campaign year from October 2017 to September 2018. The committee recommended approval of the request.

Mr. Pedigo moved to accept the Marketing and Entrepreneurship Committee Report; Mr. Henderson seconded the motion.

VOTE: Motion Passed; Unanimous.

Mr. McCloskey directed the board's attention to the GOAP financial report as of June 5, 2017 *(on file)*.

Mr. McCloskey directed the board's attention to the county account balances report as of May 25, 2017 (on file).

Mr. McCloskey reviewed the Kentucky Agricultural Finance Corporation (KAFC) Statement of Financial Position *(on file)* as of May 31, 2017.

Dr. Bailey moved to accept the KAFC Financial Report; Dean Cox seconded the motion.

VOTE: Motion Passed; Unanimous.

# **Approval to Liquidate Assets**

Mr. Doan presented a memorandum (*on file*) regarding a request to allow Central Kentucky Growers to sell the equipment purchased with Kentucky Agricultural Development funds to a third party, or to allow GOAP staff to call the forgivable loan and liquidate the assets of Central Kentucky Growers.

Mr. Henderson moved to approve the request, as presented; Dr. Jones seconded the motion.

Mr. Mattingly moved to approve the request, as presented; Dean Cox seconded the motion.

Commissioner Quarles called on Mr. McCloskey to present programs recommended for approval.

Mr. McCloskey referenced eleven (11) County Agricultural Investment Program (CAIP) applications requesting county funds totaling \$1,601,981; one (1) Deceased Farm Animal Removal Program application requesting county funds totaling \$2,500; one (1) Shared-Use Equipment Program application requesting county funds totaling \$10,013; and two (2) Youth Cost-Share Program applications requesting county funds totaling \$35,000. Total program funding requested was \$1,649,494.

Dr. Bailey moved to approve the program recommendations, as presented; Dean Cox seconded the motion.

VOTE: Motion Passed; Mr. Foree abstained.

Requested Program Amendments<sup>3</sup>

Commissioner Quarles called on Mr. McCloskey to present requested program amendments.

Mr. McCloskey referenced four (4) requested program amendments seeking additional county funds totaling \$133,105.

# **Project Recommendations for Funding**

Commissioner Quarles called on Ms. Osterman and Hannah Forte to present the following recommendations for funding:

# A2017-0091 TerrePURE Kentucky Distillers, Inc.

Ms. Osterman referenced the above application from TerrePURE Kentucky Distillers, Inc. requesting \$500,000 in State funds and \$150,000 in various County funds to construct a feedlot to feed cattle spent stillage.

The White Application Review Committee recommended funding no more than \$100,000 in the form of a grant in State funds, \$200,000 in the form of a loan in State funds and any county commitments up to half of the project costs in the form of a grant, subject to terms and conditions.

Mr. Moore moved to approve the committee recommendation; Dr. Bailey seconded the motion.

Mr. Moore mentioned potential KY Corn Growers involvement on the project.

Mr. Foree ask about the shared collateral position.

Dr. Jones asked if the legal agreement would mention use of the project for demonstration.

Mr. Doan responded that the position and demonstration usage will be mentioned in the legal agreement.

VOTE: Motion Passed; Mr. Mattingly abstained.

### A2017-0104 City of Mt. Sterling

Ms. Forte referenced the above application from City of Mt. Sterling requesting \$130,000 in State funds and \$10,000 in Montgomery County funds for the construction of a farmers market structure.

The White Application Review Committee recommended funding the request for up to \$130,000 in State and \$10,000 in County funds, subject to terms and conditions.

Dr. Bailey moved to approve the committee recommendation; Ms. Smith seconded the motion.

VOTE: Motion Passed; Unanimous.

A2017-0105 Fleming County Board of Education

Ms. Forte referenced the above application from Fleming County Board of Education requesting \$55,000 in State funds and \$10,000 in Fleming County funds for the construction of a farmers market structure.

The White Application Review Committee recommended funding the request for \$50,000 in State and \$5,000 in Fleming County funds, subject to terms and conditions.

Dr. Bailey moved to approve the committee recommendation; Mr. Mahan seconded the motion.

VOTE: Motion Passed; Unanimous.

A2017-0106 Victory Hemp Foods, LLC

Ms. Osterman referenced the above application from Victory Hemp Foods, LLC requesting \$102,002 in State funds and \$194,000 in various County funds to upgrade commercial scale equipment.

The White Application Review Committee recommended funding the request for up to \$296,002 in KADF State and County funds, subject to terms and conditions.

Mr. Mahan moved to approve the committee recommendation; Mr. Foree seconded the motion.

VOTE: Motion Passed, Unanimous.

A2017-0107 Henderson County Fair, Inc.

Ms. Osterman referenced the above application from Henderson County Fair, Inc. requesting \$5,000 in Henderson County funds to build a livestock pavilion.

The White Application Review Committee recommended funding the request for up to \$5,000 in Henderson County funds, subject to terms and conditions.

Mr. Mattingly moved to approve the committee recommendation; Mr. Pedigo seconded the motion.

VOTE: Motion Passed; Unanimous.

**Recommendation for No Funding** 

Commissioner Quarles called on Mr. McCloskey to present the following recommendation for no funding:

A2017-0108 Baesler Farms

Mr. McCloskey referenced the above application from Baeslar Farms requesting \$97,522 in State funds and \$15,000 in Fayette County funds to produce CBD oil.

The White Application Review Committee recommended no-funding A2017-0108 Baeslar Farms application to produce CBD oil due to limited producer impact and the uncertainty of the hemp status related to the Farm Bill making the longevity of the project difficult to justify KADF investment.

Dr. Bailey moved to approve the recommendation; Mr. Moore seconded the motion.

VOTE: Motion Passed; Unanimous.
