#### Call to Order

Keith Rogers, (designee for Commissioner Quarles) presiding, called the Kentucky Agricultural Development Board (KADB) regular business meeting to order at 10:02 a.m. (EDT).

#### **Roll Call**

Cox, Sarah Butler (designee for Secretary Terry Gill), Bobby Foree, Fritz Giesecke, Pat Henderson, Wayne Hunt, Dr. Gordon Jones, Jim Mahan, Wayne Mattingly, Katie Moyer, Al Pedigo and Richard Warner.

Members absent: Governor Matt Bevin, Stewart Hughes and Commissioner Quarles.

#### **Notification of Media**

Mr. Rogers received verification from Marielle Manning, Public Affairs Manager, that the media had been notified of the KADB monthly meeting.

#### Welcome

Mr. Rogers welcomed everyone to the meeting.

Mr. Rogers recapped the State budget. He stated that the Grape and Wine Council were cut from the budget, so GOAP may expect an application in the near future.

Mr. Rogers mentioned hosting Senator Mitch McConnell last month, as he discussed the Hemp Bill.

Mr. Rogers stated the Kentucky Proud wedding contest is off and running. Since its launch, it has even made National news.

Mr. Rogers recapped U.S. Agricultural Commissioner Sonny Perdue's visit last month.

Mr. Rogers mentioned the Derby kickoff luncheon today as Kentucky Proud is a sponsor of this event in Louisville.

Dr. Pomper invited everyone to Kentucky State Farm Days on May 1, 2018.

#### **Approval of Minutes**

Mr. Rogers entertained a motion to approve the minutes of the March 16, 2018 board meeting.

Mr. Mattingly moved to approve the minutes, as presented; Mr. Foree seconded the motion.

VOTE: Motion Passed; Unanimous.

#### **Executive Director's Report**

Mr. Rogers yielded the floor to Warren Beeler, Executive Director, to report to the board.

Mr. Beeler introduced Representative Phil Pratt, of Scott County, who gave the board his background and discussed agriculture.

Mr. Beeler introduced Aleta Botts, Director of KCARD. Ms. Botts reported on activities of KCARD, including eastern Kentucky projects, Rural Business Development and upcoming grants deadline.

Mr. Beeler introduced Mac Stone of Kentucky Horticulture Council. Mr. Stone informed the board that Cindy Finneseth, formerly of KCARD, was hired in a full time role as Executive Director.

Ms. Finneseth talked about her plans for the horticulture industry in her new role.

Mr. Beeler invited Farm Service Agency (FSA) Director Brian Lacefield to speak. Mr. Lacefield spoke about the omnibus bill and its impact on FSA.

Mr. Lacefield spoke about the omnibus bill and its impact on FSA.

Mr. Beeler introduced Kate McDonald, Coordinator of the "No Kid Hungry Kentucky Campaign" with the Kentucky Association of Food Banks. Ms. McDonald discussed the KVIP summer feeding program.

Ms. McDonald stated that 59 percent of applicants have never collaborated with a Kentucky grower before, and is hopeful this will have a positive impact. She stated the application deadline has been extended to May 15, 2018.

Mr. Beeler updated the board on his activities since the March 16, 2018 board meeting.

#### **Deputy Executive Director's Report**

KADB Meeting 2 April 20, 2018

Mr. Rogers yielded the floor to Bill McCloskey, GOAP Deputy Executive Director, to report to the board.

Mr. McCloskey noted a change to the board program. He requested the board refer to the Memo regarding a Shared-Use Equipment request to withdraw for Henderson County.

Mr. McCloskey directed the board's attention to the KBA PEP report from Ms. Gardner that shows the value of radio & TV commercials this year (on file).

Mr. McCloskey referenced the County Council Update Memo. He reviewed the timeline to manage the installment of the new county council membership. Current Council terms end June 30, with submission of 2018-2020 Councils due by July 31.

Ms. Gardner added that three councils, to date, have submitted a complete membership list for 2018-2020.

Mr. McCloskey reported the Compliance committee meets in May and reviewed the Quarterly Compliance Report, highlighting the list of Program Reviews completed to date.

Mr. McCloskey directed the board's attention to the GOAP financial report as of March 20, 2018 (on file).

Mr. McCloskey directed the board's attention to the county account balances report as of March 20, 2018 (on file).

Mr. McCloskey reviewed the Kentucky Agricultural Finance Corporation (KAFC) Statement of Financial Position *(on file)* as of March 20, 2018.

Mr. Warner moved to accept the KAFC Financial Report; Dr. Jones seconded the motion.

VOTE: Motion Passed; Unanimous.

#### **Recipient Review Committee Reports**

Mr. Rogers called on Pat Henderson to deliver the Kentucky Dairy Development Council (KDDC) Recipient Review Committee report.

Mr. Henderson reported the current issues in Kentucky's dairy industry. For 2017, KDDC has paid out \$356,000 in the MILK Program and is working on dairy compliance.

Mr. Henderson noted that the producer site visits by field representatives are at 100% for 2017.

The board discussed issues facing the dairy industry, including farmers dropped from Deans are looking for a market for their milk.

KADB Meeting 3 April 20, 2018

Mr. Hunt, moved to approve the committee report, as presented; Mr. Pedigo seconded the motion.

VOTE: Motion Passed; Unanimous.

Mr. Rogers called on Fritz Giesecke to deliver the Kentucky Beef Network (KBN) Recipient Review Committee report.

Mr. Giesecke reported that Kentucky Beef Network has met all its benchmarks to date.

Mr. Giesecke discussed the BQA and cattle handling and care, into what is now BQCA.

Mr. Giesecke mentioned the Beef Conference in January 2019.

Mr. Mahan moved to approve the committee report, as presented; Mr. Hunt seconded the motion.

VOTE: Motion Passed; Unanimous.

Mr. Rogers called on Pat Henderson to give the On-Farm Water Committee Report.

Mr. Henderson reported that the committee met to review application A2017-0214, Kentucky Division of Water for a project at Morehead State University under the On-Farm Water Management Program Guidelines. Mr. Henderson noted that future committee recommendation would give the board a chance to review and vote on the project. The committee recommended approval of \$52,720 in State funds for the project.

Mr. Henderson moved to approve the committee recommendation, as presented; Mr. Hunt seconded the motion.
