#### **Call to Order**

Keith Rogers, presiding, called the Kentucky Agricultural Development Board (KADB) regular business meeting to order at 9:45 a.m. (EDT).

#### Roll Call

Christopher Brown II., President), Mark Barker, Dr. Gordon Jones, Bobby Foree, Fritz Giesecke, Pat Henderson, Matthew Hinton, Wayne Hunt, Stewart Hughes, Jim Mahan and Al Pedigo.

Members absent: Governor Bevin, Katie Moyer.

#### **Notification of Media**

Mr. Rogers received verification from Marielle McElmurray, Director of Public Affairs, that the media had been notified of the KADB monthly meeting.

#### Welcome

- Mr. Rogers welcomed everyone to the meeting.
- Mr. Rogers stated the Commissioner was in Paducah for meetings.
- Mr. Rogers stated the Kentucky Department of Agriculture (KDA) is inspecting gas pumps and have found a brand new skimmer technique in Louisville that is circulating now.
- Mr. Rogers mentioned that KDA is preparing for the Kentucky Derby events.
- Mr. Rogers yielded the floor to Chad Smith, Director of Promotion and Development Division in the Marketing Office of KDA, to give an update on the KDA Derby festivities.
- Mr. Rogers stated the third weekend in May, KDA would be involved in the Chicago Food Show to represent Kentucky Proud.
- Mr. Rogers stated that Greg Ibach, USDA Undersecretary for Marketing and Regulatory Programs, (MRP) was in Lexington last week for a forum on hemp with Senator Rand Paul.
- Mr. Rogers stated the FDA has announced the first public hearing on CBD oil, to be held on May 31, 2019 in Washington, D.C. with the new acting administrator.

- Mr. Rogers gave the most recent numbers regarding hemp sales. Sales from producers \$57.75 million; farmers were paid \$17.75 million; Capital investments \$23.4 million and 457 employed not counting farmers/growers.
- Mr. Rogers stated that Kentucky has issued 978 growers licenses for hemp for 2019.
- Mr. Rogers stated EPA Administrator Andrew Wheeler was in Louisville with the Governor for the annual They're Off Luncheon.

- Mr. Beeler yielded the floor to Brian Lacefield, State Farm Service Agency Director, to give an update to the board.
- Mr. Beeler yielded the floor to Aleta Botts, Executive Director of the Kentucky Center for Rural Development, (KCARD) to update the board on the status of the organization.
- Ms. Botts mentioned she has recently received many calls from businesses realizing they are not doing well. She is encouraging anyone who knows of a business that is struggling to have them call KCARD.
- Ms. Botts invited everyone to the KCARD board meeting on Friday, April 26, 2019.
- Mr. Beeler yielded the floor to Dr. Chad Lee, Executive Director of the UK Grain and Forage Center of Excellence, to report on the progress of the buildings expansion.
- Mr. Beeler yielded the floor to Whitney Carmen, Grayson County ANR Agent, to report to the board.
- Mr. Beeler recognized Grace Ragain with a plaque for her time as a GOAP intern.
- Mr. Beeler updated the board on his activities since the last board meeting.

- Mr. Rogers yielded the floor to Bill McCloskey, GOAP Deputy Executive Director, to report to the board.
- Mr. McCloskey called on Sandra Gardner to give the KADB Winter Quarterly Compliance Report (on file), to the board.
- Ms. Gardner yielded the floor to Shelby Wade to present KADB success stories to the board.
- Mr. McCloskey directed the board's attention to the Kentucky Broadcasters Association Public Education Partnership report (*on file*).
- Mr. McCloskey addressed the State Pool Tobacco Funds as of March 29, 2019 (on file).

Mr. McCloskey addressed the March 29, 2019 KADB Cash flow (on file).

Mr. McCloskey directed the board's attention to the county account balances report as of March 19, 2019 (on file).

Mr. McCloskey reviewed the Kentucky Agricultural Finance Corporation (KAFC) Statement of Financial Position (on file) as of March 31, 2019.

Mr. McCloskey referenced the April 12, 2019 KAFC Meeting Agenda and the KAFC Loan Applications (on file).

Mr. Foree moved to accept the KAFC Financial Report; Mr. Hughes seconded the motion.

VOTE: Motion Passed; Unanimous.

#### **Memo Action Items**

Mr. Rogers called on Steve Doan, Sadie Middleton, Renee Laurent and Danielle Milbern to present the following memo action items:

#### A2003-0477 River Valley Winery, Inc.

Mr. Doan presented a memorandum (on file) on the above referenced project regarding the River Valley Winery, Inc. request for a forgivable loan settlement agreement. Due to inclement weather and changes in the laws governing Kentucky wineries, the Recipient has been unable to purchase the necessary quantity of grapes and juice from Kentucky producers to meet its obligations.

The KADB Compliance Committee directed staff to negotiate a settlement for the outstanding debt (\$13,684). The Recipient agreed to \$2,000 to settle.

Staff recommends approval.

Staff recommends approval.

In response to a question from Mr. Pedigo, Ms. Middleton stated that the last \$5 million transfer of money to KAFC was May of 2018.

Mr. Pedigo moved to approve the recipient request; Mr. Henderson seconded the motion.
