Call to Order

Commissioner Quarles, presiding, called the Kentucky Agricultural Development Board (KADB) regular business meeting to order at 10:06 a.m. (EDT).

Roll Call

The following members were present: Commissioner Quarles, presiding, Sarah Butler (designee for acting Secretary Vivek Sarin), Dean Nancy Cox, Dr. Kirk Pomper (designee for Dr. M. Christopher Brown II., President), Mark Barker, Bobby Foree, Fritz Giesecke, Pat Henderson, Matt Hinton, Wayne Hunt, Stewart Hughes, Katie Moyer and Al Pedigo.

Members absent: Governor Bevin, Jim Mahan, Dr. Gordon Jones.

Notification of Media

Commissioner Quarles received verification from Marielle McElmurray, Director of Public Affairs, that the media had been notified of the KADB monthly meeting.

Welcome

Commissioner Quarles welcomed everyone to the meeting.

Commissioner Quarles recognized the 2019 Kentucky Department of Agriculture (KDA) summer interns.

Commissioner Quarles recognized Lance Terrell for his service at KDA.

Commissioner Quarles stated that Kentucky is on target to have 200 hemp processors this year.

Commissioner Quarles stated that KDA has a new employee, Alex Franke, current Miss Kentucky.

Commissioner Quarles announced that Patagonia American Clothing Company is collaborating with a Bourbon County hemp farm to source hemp fiber for its clothing.

Executive Director's Report

Commissioner Quarles yielded the floor to Warren Beeler, GOAP Executive Director, to report to the board.

Mr. Beeler mentioned to keep Mr. Mahan in your thoughts and prayers as he is in the hospital.

Mr. Beeler introduced Rob Goff, GOAP General Counsel.

Mr. Beeler yielded the floor to Aleta Botts, Executive Director of the Kentucky Center for Agriculture and Rural Development (KCARD), to update the board on the status of the organization.

Mr. Beeler yielded the floor to Dr. Chad Lee, Executive Director of the UK Grain and Forage Center of Excellence, to report on the progress of the center and speak about the UK AG Benefactor Program.

Mr. Beeler yielded the floor to Metcalfe County Family Consumer and Science Extension Agent, Lynn Blankenship, to address the board.

Mr. Beeler updated the board on his activities since the last board meeting.

Approval of Minutes

Commissioner Quarles entertained a motion to approve the minutes of the May 17, 2019 board meeting.

Ms. Moyer moved to approve the minutes, as presented; Mr. Barker seconded the motion.

VOTE: Motion Passed; Unanimous.

Deputy Executive Director's Report

Commissioner Quarles yielded the floor to Bill McCloskey, GOAP Deputy Executive Director, to report to the board.

Mr. McCloskey directed the board's attention to the Kentucky Broadcasters Association Public Education Partnership report (*on file*).

Mr. McCloskey addressed the State Pool Tobacco Funds as of June 2, 2019 (*on file*).

Mr. McCloskey addressed the June 2, 2019 KADB Cash Flow (*on file*).

Mr. McCloskey directed the board's attention to the county account balances report as of May 24, 2019 (*on file*).

Mr. McCloskey reviewed the Kentucky Agricultural Finance Corporation (KAFC) Statement of Financial Position (*on file*) as of May 31, 2019.

Mr. McCloskey referenced the June 14, 2019 KAFC Meeting Agenda and the KAFC Loan Applications (*on file*).

Mr. Hinton moved to accept the KAFC Financial Report; Mr. Pedigo seconded the motion.

VOTE: Motion Passed; Unanimous.

Memo Action Items

Commissioner Quarles called on Bill McCloskey and Danielle Milbern to present the following memo action items:

A2008 - 0280 Foothills Products and Services, Inc.

Mr. McCloskey presented a memorandum (*on file*) on the above referenced project requesting a loan modification for Foothills Country Meats.

The KADB Compliance Committee recommended extending the current deferred payment plan of \$650 per month with a credit of up to \$450 per month, based on salary paid for marketing personnel for three years with a balloon payment at the end of the extended term. The maturity date would be 7/15/2022 and the final balloon payment is estimated to be \$397,515. The KADB Compliance Committee recommends approval.

Mr. Foree moved to approve the committee recommendation, as presented; Ms. Butler seconded the motion.

VOTE: Motion Passed; Unanimous.

A2018 – 0095 Lincoln County Fiscal Court

Ms. Milbern presented a memorandum (*on file*) on the above referenced project requesting a six (6) month time extension until January 27, 2020 to complete its project.

Staff recommends approval.

Mr. Hughes moved to approve the staff recommendation, as presented; Mr. Giesecke seconded the motion.

VOTE: Motion Passed; Unanimous.

A2018 - 0098 Warren County Conservation District

Ms. Milbern presented a memorandum (*on file*) on the above referenced project requesting a 30-day time extension until August 27, 2019 to complete its project. The GOAP staff recommends a 3-month time extension until October 27, 2019 to complete the project.

Staff recommends approval.

Mr. Hunt moved to approve the staff recommendation, as presented; Ms. Moyer seconded the motion.

VOTE: Motion Passed; Unanimous.

A2018 - 0099 Warren County Extension District Board

Ms. Milbern presented a memorandum (*on file*) on the above referenced project requesting a budget amendment to reallocate \$5,000 in funds that will not be used based on the original budget as some of the items purchased were below budgeted amounts. The reallocated funds would be used towards the purchase of a \$47,425 commercial kitchen hood. The recipient is also requesting a 60-day extension until August 1, 2019 to submit final invoices.

The White Application Review Committee recommends approving a budget amendment and 6-month time extension.

Mr. Henderson moved to approve the committee recommendation, as presented; Mr. Hinton seconded the motion.

VOTE: Motion Passed; Unanimous.

A2018 - 0201 Kentucky Dairy Development Council (KDDC)

Ms. Milbern presented a memorandum (*on file*) on the above referenced project requesting a reallocation of funds from the remaining 2018 MILK funds. The KDDC is requesting the funds go to a new USDA Dairy Margin Coverage (DMC) Cost-Share Program budget category.

Ms. Milbern yielded the floor to H.H. Barlow to explain the Cost-Share Program.

The KDDC Recipient Review Committee recommends approving the transfer of \$185,498 in 2018 MILK funds for a new budget category for DMC cost-share to assist producers who sign up for the 5-year, \$9.50 option reimbursing half, up to \$1,000, of the 1st year premium for 2019.

Mr. Hinton moved to approve the committee recommendation, as presented; Mr. Hunt seconded the motion.

VOTE: Motion Passed; Unanimous.

At this time, Commissioner Quarles yielded the gavel to Keith Rogers to chair the meeting.

New Business

Mr. Rogers called on Mr. McCloskey to present new applications for referral.

Mr. McCloskey referenced twelve (12) new applications for referral.

Mr. Hunt moved to refer the submitted applications to the appropriate committees; Ms. Butler seconded the motion.

Programs Recommended for Approval

Commissioner Quarles called on Mr. McCloskey to present programs recommended for approval.

Mr. McCloskey referenced (14) County Agricultural Investment Program (CAIP) applications requesting county funds totaling \$1,977,859; Six (6) Deceased Animal Removal Program applications requesting county funds totaling \$38,547; One (1) Next Generation Farmer application requesting county funds totaling \$21,679; Two (2) Youth Ag Incentives Program applications requesting county funds totaling \$50,000; This makes the total programs funding \$2,088,085.

Mr. Henderson moved to approve the approve with amendments, as presented; Mr. Foree seconded the motion.

VOTE: Motion Passed; Unanimous.

Requested Program Amendments

Mr. Rogers called on Mr. McCloskey to present requested program amendment.

Mr. McCloskey referenced five (5) counties requesting additional funds, or a modification to their legal agreement for existing CAIPS; (Owen, Graves, Simpson, Spencer and Trigg counties) for a total additional funding of \$462,233.

Mr. Barker moved to approve the program amendments as presented; Mr. Giesecke seconded the motion.

VOTE: Motion Passed; Unanimous.

A2019-0103 Metcalfe County Extension District Board

Ms. Milbern referenced the above application requesting \$190,000 in State funds and \$10,000 in Metcalfe County funds for the construction of a larger farmers market structure and to enclose and purchase equipment for the pavilion.

The White Application Review Committee recommends funding the request for up to \$10,000 in Metcalfe County funds and \$190,000 in State funds, subject to terms and conditions.

Mr. Giesecke moved to approve the committee recommendation, as presented; Mr. Pedigo seconded the motion.

A2019 - 0104 Metcalfe County 4-H Council, Incorporated

Ms. Milbern referenced the above application requesting \$1,350 in Metcalfe County funds to purchase 18 hams for the Metcalfe County 4-H.

Mr. Hughes moved to approve the committee recommendation, as presented; Mr. Barker seconded the motion.

A2019-0107 Pendleton County Extension District Foundation, Incorporated

Ms. Milbern referenced the above application requesting \$90,000 in State funds and \$10,000 in Pendleton County funds for a farmers market project.

The White Application Review Committee recommends funding the request for up to \$90,000 in State funds and \$10,000 in Pendleton County funds, subject to terms and conditions.

Mr. Hinton moved to approve the committee recommendation, as presented; Ms. Moyer seconded the motion.

VOTE: Motion Passed; Unanimous.

A2019-0109 Christian County Agricultural Extension Foundation, Inc.

Mr. McCloskey referenced the above application requesting \$250,000 in Christian County funds to construct an exposition facility.

The White Application Review Committee recommends funding the request for up to \$250,000 in Christian County funds, subject to the terms and conditions.

Ms. Gardner noted a change in the terms, a moratorium from "equipment for five (5) years" to "facility for ten (10) years."

Mr. Henderson moved to approve the committee recommendation, as presented; Ms. Butler seconded the motion.

VOTE: Motion Passed; Mr. Hunt abstained.

A2019-0119 Wise Meat Packing

Ms. Milbern referenced the above application requesting \$25,124 in State funds and \$25,124 in Taylor County funds to purchase new filling and clipping equipment.

The White Application Review Committee recommends funding the request for up to \$50,248 of the total budget in multiple county funds, and denying the state funds.

Mr. Pedigo moved to approve the committee recommendation, as presented; Mr. Hunt seconded the motion.

VOTE: Motion Passed; Unanimous.

A2019-0120 Western Kentucky State Fair, Inc.

Mr. McCloskey referenced the above application requesting \$60,975 in multiple county funds to upgrade infrastructure at the fairgrounds.

The White Application Review Committee recommends funding the request for up to \$60,975 of the total budget in multiple county funds, and denying the state funds.

Mr. Hughes moved to approve the committee recommendation, as presented; Mr. Giesecke seconded the motion.

VOTE: Motion Passed; Unanimous.

A2019-0121 Kentucky State Fair Board

Mr. McCloskey referenced the above application requesting \$1,500,000 in State funds for a Traffic Engineering Study of Gate One and construction of Freedom Hall Make-up Ring at the Kentucky Fair & Exposition Center.

The White Application Review Committee recommends funding the request for up to \$1,500,000 in State funds, subject to terms and conditions.

Mr. Barker moved to approve the committee recommendation, as presented; Mr. Hinton seconded the motion.

VOTE: Motion Passed; Unanimous.

A2019-0127 McLean County 4-H Council

Mr. McCloskey referenced the above application requesting \$7,680 in McLean County funds to purchase small animal holding pens.

The White Application Review Committee recommends funding the request for up to \$7,680 in McLean County funds, subject to terms and conditions.

On-Farm Energy Incentives Program

Ms. Osterman presented a memorandum (*on file*) on the above referenced requests regarding funds request for seventeen (17) programs for a total of \$141,307.

Mr. Pedigo moved to approve the recommendation, as presented; Ms. Butler seconded the motion.

Mr. McCloskey referenced the above On-Farm Energy application, requesting \$10,500 to install curtains for insulation.

The On-Farm Energy Committee recommended no funding due to the Joint KADB/KAFC Policy on hemp stating only applications related to education and certified seed for 2019 would be considered for funding. This project relates to energy improvement.

Mr. Hinton moved to approve the committee recommendation, as presented; Mr. Barker seconded the motion.

B. Memo (Dairy Margin Cost-Share Program)

1. The KDDC RRC recommends, "Using the \$185,498 to make a Dairy Margin Cost-Share Program to pay half of the Dairy Margin Coverage Program insurance premium up to \$1,000 at the \$9.50 rate. Dairy farmers must sign-up for a five year plan. The cost-share program is only for 2019."
