- a) Allison Porteus gave an update from a recent meeting with KCTCS about what is needed for Kentucky's Workforce Development training.
- b) KCTCS is very accepting of this training idea and will be looking further into the details to make it happen. They mentioned possibly using virtual reality or partnering with local meat processors for hands-on experience.
- c) Allison will be enrolling one of her employees in the Bridgewater Program to see how it is structured and get ideas.

2. Kentucky Association of Meat Processors (KAMP) Update

- a) Allison Porteus introduced, newly hired Executive Secretary, Jennifer Hardin to give an update.
- b) Jennifer Hardin updated committee members that there are currently 7 members signed up with hopes for more from future events and contacts. KAMP will be hosting a Brats & Bourbon Tour event in September 2023 with the Indiana Packers.

3. A2023-0089 JSW Farm Chop Shop

- a) Jonathan Whitt, Bobby Pace, and Jon Lett gave a description of their Beef Tripe Processing Project. This addition will allow them to earn income from products that have previously been thrown out (omasum, honeycomb tripe, and regular tripe) and process approximately 200 head a day versus the 160 they currently do.
- b) Dr. Gordon Jones made a motion to refer the application to Kentucky Agricultural Finance Corporation. Brenda Paul seconded the motion.
