Call to Order

Commissioner Ryan Quarles, presiding, called the Kentucky Agricultural Finance Corporation Board (KAFC) regular business meeting to order at 10:12 a.m. (EST).

Commissioner Quarles received verification from Marielle McElmurray, Director of Public Affairs, that the media had been notified of the KAFC board meeting.

Commissioner Quarles welcomed everyone to the meeting.

Commissioner Quarles discussed some of the topics at the recent National Association of State Departments of Agriculture (NASDA) conference he attended.

Commissioner Quarles stated that Kentucky will host the 2021 NASDA in Louisville.

Commissioner Quarles stated that on April 8, 2019, there will be a hemp listening session in Louisville, Senator McConnell and Under Secretary of Agriculture Greg Ibach will attend.

Commissioner Quarles stated that the grain indemnity bill and the fake meat bill have passed through both chambers of state legislature.

Commissioner Quarles stated that the Serving Up Solutions event raised \$50,000 going to feed the hungry in Kentucky.

Commissioner Quarles yielded the floor to Mr. Penn for Santa Anita racetrack update and discussion of Kentucky equine economic effect.

Commissioner Quarles called on Hilda Legg, State Director for the U.S. Department of Agriculture's Office of Rural Development in Kentucky to address the board.

Ms. Legg updated the board on the where grant money has been distributed recently, with an emphasis on family housing, summer meals initiative and broadband in KY.
