Staff recommends approval with a C/LV no greater than 85%.

Applicants requested \$250,000 for the purchase of four (4) Keystone broiler houses and 86 acres in Monroe County. Citizens Bank in Hiseville, KY is the participating lender.

Staff recommends approval contingent upon the approval and obligation of a 90% FSA guarantee on Citizens Bank and KAFC funds with a C/LV no greater than 75%.

AF19-0035 Armour, Jackson

Applicants requested \$250,000 for the purchase of four (4) Perdue broiler barns in McLean County. Farm Credit Mid-America in Owensboro, KY is the participating lender.

Staff recommends approval with a C/LV no greater than 85%.

AF19-0036 Toon, Sumittra (Toon Poultry, Inc.)

Applicant requested \$250,000 for the purchase of three (3) Pilgrim's Pride pullet barns in Graves County. River Valley AgCredit in Bardwell, KY is the participating lender.

The Loan Review Committee recommends approval under the AILP for up to \$100,000 with a C/LV no greater than 85%.

Mr. Lawson moved to approve committee recommendation, as presented, pending availability of funds; Mr. Noe seconded the motion.

VOTE: Motion Passed; Unanimous.

AF19-0037 Reed, Sarah

Applicants requested \$187,500 for the purchase of 69 acres in Shelby County. Farm Credit Mid-America in Shelbyville, KY is the participating lender.

Staff recommends approval with a C/LV no greater than 85%.

Ms. Amburgey moved to approve staff recommendation, as presented, pending availability of funds; Mr. Jaggers seconded the motion.

In response to a question from Ms. Rumpke, staff stated they will obtain a credit score for the co-applicant.

VOTE: Motion Passed; Unanimous.

AF19-0038 Bowman, M. Elliot

Applicants requested \$64,000 for the purchase of 25 acres in Barren County. South Central Bank of Barren County in Glasgow, KY is the participating lender.

Staff recommends approval contingent upon the approval and obligation of a 90% FSA guarantee on South Central Bank of Barren County and KAFC funds with a C/LV no greater than 100%.

Mr. Lawson moved to approve committee recommendation, as presented, pending availability of funds; Mr. Hunt seconded the motion.

VOTE: Motion Passed; Unanimous.

AF19-0039 Ebelhar, M. Scott

Applicant requested \$250,000 for the purchase of 223 acres in LaRue County. Farm Credit Mid-America in Elizabethtown, KY is the participating lender.

Staff recommends approval with a C/LV no greater than 65%.

Mr. Jaggers moved to approve staff recommendation, as presented, pending availability of funds; Ms. Rumpke seconded the motion.

VOTE: Motion Passed; Unanimous.

AF19-0040 McCarty, Keaton

Applicants requested \$142,500 for the purchase of 89 acres in Montgomery County. Traditional Bank in Mt. Sterling, KY is the participating lender.

The Loan Review Committee recommends approval with a C/LV no greater than 85%.

Mr. Lawson moved to approve the committee recommendation, as presented, pending availability of funds; Ms. Rumpke seconded the motion.

VOTE: Motion Passed; Unanimous.

AF19-0042 Latham, Egan

Applicant requested \$127,382.50 for the purchase of 122 acres in Clinton County. Farm Credit Mid-America in Somerset, KY is the participating lender.

Staff recommends approval with a C/LV no greater than 85%.

Mr. Noe moved to approve staff recommendation, as presented, pending availability of funds; Dr. Burdine seconded the motion.

VOTE: Motion Passed; Unanimous.

AF19-0043 Gilles, Brandon (Gilles Land Company, LLC)

Applicant requested \$198,467 for the purchase of 86 acres in Daviess County. Central Kentucky ACA in Lebanon, KY is the participating lender.

Staff recommends approval with a C/LV no greater than 85%.

Dr. Burdine moved to approve staff recommendation, as presented, pending availability of funds; Mr. Penn seconded the motion.

VOTE: Motion Passed; Unanimous.

AF19-0044 Bennett, Zachary

Applicants requested \$250,000 for the purchase of 103 acres in Shelby County. Citizens Union Bank in Shelbyville, KY is the participating lender.

Staff recommends approval with a C/LV no greater than 80%.

Mr. Jaggers moved to approve staff recommendation, as presented, pending availability of funds; Mr. Hunt seconded the motion.

VOTE: Motion Passed; Unanimous.

AF19-0045 DiGiannantonio, Heather (BellaVia Farm, LLC)

Applicant requested \$200,000 for the purchase of 20 acres with a horse barn in Shelby County. Citizens Union Bank in Shelbyville, KY is the participating lender.

Staff recommends approval with a C/LV no greater than 65%.

Mr. Penn moved to approve staff recommendation, as presented, pending availability of funds; Ms. Rumpke seconded the motion.

VOTE: Motion Passed; Unanimous.

Extensions

AF17-0035 Hunter, John Eric

This request is for a six (6) month extension to allow adequate time for the project to be completed. The new expiration date will be October 12, 2019.

Staff recommends approval.

AF19-0006 Alford, Andy

AF18-0090 Wood Farms Poultry

This request is for the combined loan-to-value limit to be increased to 85%.

Staff recommends approval.

AF18-0114 Twin Lakes Poultry

This loan officer has indicated that the KAFC Letter of Commitment incorrectly indicated a UCC would be filed and a Kenergy contract would be made to the customer. A mortgage and final title will be provided. The request is for the Board to waive these two requirements.

Staff recommends approval.

Mr. Hunt moved to approve staff recommendation, as presented, pending availability of funds; Mr. Brady seconded the motion.

VOTE: Motion Passed: Unanimous.

AF19-0129 Woodruff, Heather

This request is for the Board to waive the FSA requirement.

Staff recommends approval.

In response to a question from Mr. Lawson, staff stated that the C/LV is less than 85% and credit scores and income are sufficient.

Ms. Amburgey moved to approve staff recommendation with a C/LV no greater than 85%, pending availability of funds; Mr. Noe seconded the motion.

VOTE: Motion Passed; Unanimous.

Closing Remarks

Mr. Beeler brought to the Board's attention the request for \$5 million from the KADB in April.

Ms. Rumpke asked that the KAFC communicate with loan officers that there may be delay in approval of loans due to lack of funds.

Mr. Hunt stated there will be significant discussion at the KADB meeting regarding the request.

Ms. Rumpke asked how the Board will prioritize applications if the request is not met by the KADB. The KAFC Strategic Planning Committee may potentially look at other funding sources for KAFC.

Mr. Penn stated the KADB County funds can be available for regional processing projects. Mr. Penn stated the future of agriculture will rely on leveraging money and vertical integration.

Mr. Hunt asked that the Board consider inviting a group of bankers and lenders who have utilized KAFC funding to testify to the Board and other organizations in the future regarding the impact of these loans.

Adjournment

Mr. McCauley entertained a motion to adjourn.

Ms. Amburgey moved to adjourn the KAFC board meeting; Mr. Lawson seconded the motion.
