Mr. Hughes received verification from Marielle McElmurray, Director of Public Affairs, that the media had been notified of the KAFC board meeting.

Welcome

Mr. Hughes welcomed everyone to the teleconference meeting. Mr. Hughes updated the board on activities of the Kentucky Department of Agriculture (KDA), Kentucky State Fair and and COVID-19 impacts on agriculture.

Loan Review Committee Report

Mr. Hughes called on Ms. Rumpke to give the Loan Review Committee report. Ms. Rumpke stated that the loans reviewed would be discussed in order of the agenda. Due to a meeting conflict, Ms. Rumpke noted that Mr. Lawson and Mr. Noe would present the committee's recommendations.

New Business

Mr. Hughes called on Mr. McCloskey, Ali Hulett and Lindsay Bates to present the following applications.

Agricultural Processing Loan Program (APLP)

AF20-0059 Voet, Douglas

Applicants requested \$500,000 for the purchase and improvements of 15 acres with a distillery in Fulton County. The Citizens Bank of Hickman in Hickman, KY is the participating lender.

The Loan Review Committee recommended to pend the application until further guidance is received from the KADB.

Mr. Lawson moved to approve the committee recommendation to pend the application; Mr. Noe seconded the motion.

VOTE: Motion Passed: Unanimous.

AF20-0061 Nichols, Joel

Applicant requested \$399,270 for the purchase and update of an existing building with straw blanket manufacturing equipment in Trigg County. Community Financial Services Bank in Benton, KY is the participating lender.

The Loan Review Committee recommended to approve the application for up to \$150,000.

Mr. Lawson moved to approve the committee recommendation; Ms. Amburgey seconded the motion.

In response from a question by GOAP staff, Mr. Lawson clarified the C/LV would remain at 75% with only land being used as collateral.

VOTE: Motion Passed; Unanimous.

AF20-0068 Rock, Samuel

Applicants requested \$1,317,500 for the purchase of 61 acres and construction of a distillery and warehouse in Woodford County. South Central Bank of Lexington in Lexington, KY is the participating lender.

The Loan Review Committee recommended to pend the application until future guidance is received from the KADB.

Mr. Noe moved to approve the committee recommendation, as presented; Ms. Amburgey seconded the motion.

In response to a question from Mr. Penn, Mr. Hunt clarified distillery funding based on producer impact, loan structure and size guidance would be discussed by the KADB.

VOTE: Motion Passed; Unanimous.

AF20-0069 Case, Russell

Applicant requested \$143,444 for the purchase of equipment for a malthouse in Harrison County. Kentucky Bank in Cynthiana, KY is the participating lender.

The Loan Review Committee recommended to approve.

Mr. Noe moved to approve the committee recommendation, as presented; Mr. Adams seconded the motion.

VOTE: Motion Passed; Unanimous.

Beginning Farmer Loan Program (BFLP)

AF20-0062 Bewley, William

Applicant requested \$84,000 for the purchase of 28 acres in Hardin County. Magnolia Bank in Elizabethown, KY is the participating lender.

Staff recommended approval, contingent upon the approval and obligation of a 95% FSA guarantee on Magnolia Bank and KAFC funds, with C/LV no greater than 100%.

Mr. Adams moved to approve the staff recommendation, as presented, pending availability of funds; Mr. Jaggers seconded the motion.

VOTE: Motion Passed; Unanimous.

AF20-0063 Stone, Ryan

Applicant requested \$250,000 for the purchase of 59 acres with (4) Cobb-Vantress breeder barns in Clinton County. Farm Credit Mid-America in Somerset, KY is the participating lender.

Staff recommends approval, contingent upon the approval and obligation of a 95% FSA guarantee on Farm Credit and KAFC funds, with C/LV no greather than 100%.

Mr. Penn moved to approve the staff recommendation, as presented, pending availability of funds; Dr. Burdine seconded the motion.

VOTE: Motion Passed; Unanimous.

AF20-0064 Ayer, Kyle

Applicant requested \$250,000 for the refinance of 30 acres with four (4) Perdue broiler barns in McLean County. Farm Credit Mid-America in Owesboro, KY is the participating lender.

The Loan Review Committee recommended to deny based on program guidelines that refinancing is not eligible.

Mr. Lawson moved to deny the request, based on the committee's recommendation; Ms. Amburgey seconded the motion.

VOTE: Motion Passed; Unanimous.

AF20-0065 Schroeder, Jacob

Applicant requested \$250,000 for the purchase of 190 acres with equestrian center in Hardin County. First Financial Bank in Louisville, KY is the participating lender.

Staff recommended approval, with C/LV no greater than 85%.

Ms. Amburgey moved to approve the staff recommendation, as presented, pending availability of funds; Mr. Jaggers seconded the motion.

VOTE: Motion Passed; Unanimous.

Mr. Penn recommended the applicant be encouraged to purchase significant liability and casualty insurance, due the nature of the business.

AF20-0066 Long, Joshua

Applicant requested \$235,000 for the purchase of 183 acres in Madison County. Central Kentucky ACA in Richmond, KY is the participating lender.

Staff recommended approval, contingent upon the approval and obligation of a 95% FSA guarantee on Central Kentucky ACA and KAFC funds, with a C/LV no greater than 100%.

Mr. Penn moved to approve the staff recommendation, as presented, pending availability of funds; Mr. Adams seconded the motion.

VOTE: Motion Passed; Mr. Noe abstained.

AF20-0067 Reynolds, Daniel

Applicant requested \$201,875 for the purchase of 95 acres in Taylor County. Central Kentucky ACA in Lebanon, KY is the participating lender.

Staff recommended approval, contingent upon the approval and obligation of a 90% FSA guarantee on Ag Credit and KAFC Funds, with C/LV no greater than 100%.

Mr. Adams made a motion to approve the staff recommendation, as presented, pending availability of funds; Mr. Jaggers seconded the motion.

VOTE: Motion Passed; Mr. Noe abstained.

Old Business:

Mr. Hughes called on Ms. Hulett to present the following extensions/modifications.

Modifications

AF17-0023 Hagan, Dustin

Ms. Hulett presented a memorandum (on file) regarding the above referenced loan and AF17-0071. The loan officer requested an approval modification to release Mr. Jason Hagan from liability on the 44 acres and subordinate to the \$289,00 Rural First home debt into a third lien position for Mr. Dustin Hagan.

The Loan Review Committee recommended to pend until additional information has been received.

Mr. Lawson moved to pend the request, based on the committee's recommendation; Ms. Amburgey seconded the motion.

VOTE: Motion Passed: Unanimous.

AF20-0048 Hymer, Johnnie

Ms. Hulett presented a memorandum (on file) regarding the above referenced loan. The loan officer requested an approval modification to remove the FSA guarantees from the real estate notes.

The Loan Review Committee recommended to approve.

Mr. Noe moved to approve the committee recommendation, as presented; Mr. Adams seconded the motion.

VOTE: Motion Passed; Unanimous.

Closing Remarks

Mr. Hughes informed the board the next meeting will be Friday, September 11 at 10 a.m. EDT.

In response to the two pended applications, GOAP staff stated information will be presented to the KADB at its August board meeting for further guidance on distillery funding.

Mr. Hughes also mentioned the upcoming Linking Agriculture for Networking and Development (LAND) forums and invited board members and staff to attend via teleconference.
