**Gentlemen:**

We hereby open our Irrevocable Letter of Credit in your favor for the principal amount of (\$ \_\_\_\_\_ ) for a sum or sums not exceeding a total of (\$ \_\_\_\_\_ ) (\$ \_\_\_\_\_ ) available by your written demand(s) for payment or your draft(s) on us at Sight when accompanied by Notice of Insufficient Grain and an Authorization to Receive Payment Letter signed by the State Board of Agriculture, Commissioner of Agriculture or Authorized Agent per draft or per demand.

It is a condition of this Letter of Credit that it will be automatically extended for additional period of up to one (1) year from the then relevant expiry date unless ninety (90) days prior to that relevant expiry date, we notify you that we elect not to extend this Letter of Credit whereupon you may elect either to obtain cash collateral by drawing your one sight draft on us for an amount not to exceed the unused balance of the letter of Credit, or to let the Letter of Credit expire.

For the purposes of this credit, our notice not to extend shall mean:

- 1) that we send our notification to you at the above listed address by registered mail (return receipt requested) dated not less than ninety (90) days prior to expiration; and
- 2) that, in the event, prior to fifteen (15) days before the then relevant expiry date, we have not received either your draft on us, we will hand deliver our notification to and obtain a receipt from: Manager, Grain, Department of Agriculture, or the official's designated representative, not less than five (5) days prior to the then relevant expiry date. In the event we shall have failed to notify you as described above, this Letter of Credit shall be automatically extended for a period of one (1) year; and

3) that, in the event you draw your draft upon us in response to our notice not to extend, such draft need not be accompanied by a Notice of Insufficient Grain.
